

**Heartland Presbytery
MINUTES
February 20, 2010**

The Presbytery of Heartland met for its 198th Stated Meeting on Saturday, February 20, 2010, in the sanctuary of the Southminster Presbyterian Church, 6303 Roe Avenue, Prairie Village, Kansas.

Convening Activities

At 9:04 a.m., Moderator Jack Schrimsher convened the meeting with three raps of his gavel and then led the presbytery in an opening prayer.

The presence of a **quorum** was declared by the Stated Clerk.

Adoption of the Docket

The Stated Clerk made the following corrections to the docket:

Page 2, Item D: Insert at the end “in 2010.”

Page 2, Item F: Remove it, as it is covered in detail under the Council report.

Page 3, Item C: The Administrative Commission motion for First, KCKS can be completed by filling in the date of June 2, 2010.

Page 12, Item A: Change the starting date for Rev. Carlson to March 15

Page 12, Item C: Change the starting date for Rev. Perucca to March 1, 2010, and “Deferred Comp” to “Dental”.

Page 12, Item D: Change the starting date for Rev. Florio to March 11, 2010.

Page 13, Item E: Add “Moving Expenses up to \$4,000 total shared equally between the two churches”

Rev. Davis Young moved approval of the docket as amended. It was seconded and approved.

Building Community

Rev. Jeff Clayton, host pastor, welcomed the presbytery to Southminster.

Several **First-time Commissioners** were introduced.

It was seconded and approved.

There were several announcements for the Good of the Community including the “Embracing Hope” January event which was attended by over 200 persons; various fundraisers at area churches were noted; an invitation to the Spring PW Gathering and Festival of Peacemaking on April 24; the April 13-14 presentation by President of McCormick Theological Seminary, Dr. Cynthia Campbell at HPC through the Omaha Seminary Foundation,; an invitation from Cherith Brook to volunteer at their mission site or

participate in various peacemaking witnessing events; and an invitation from First, Pleasant Hill, MO to attend presbytery in their church on April 18.

Preparing for Worship

Joys and Concerns for Prayer were shared including Moderator Jack Schrimsher' upcoming foot surgery; Marcus Cumpton gave thanks to God for his new grandchild; prayers for safe travel for Kaw Prairie's first international trip over spring break to Mexico; prayers for Haiti and our Haiti Christian Fellowship which has lost 35 family members in the earthquake; and hope was expressed that spring would come prior to the April 20th meeting of presbytery in Pleasant Hill, MO.

Worship including the Lord's Supper and Installation of the 2010 Presbytery Moderator Rev. Chad Herring

The Rev. Landon Whitsitt and Rev. Chad Herring presided during the service of worship. The Moderator of the Presbytery 2010 Rev. Chad Herring was installed and outgoing Moderator Elder Jack Schrimsher was thanked for his service and received an engraved Moderator's Cross as a gift of gratitude from the presbytery.

Presentation of the Consent Agenda

Stated Clerk Rev. Maryann Farnsworth presented the Consent Agenda as follows:

(A.) The Trustees recommended and moved that Heartland Presbytery grant permission to the congregation of NorthEastminster Presbyterian Church, 301 Van Brunt Blvd, Kansas City, MO 64124 to sell the property and building located at 217 Benton Blvd, Kansas City, MO 64124 (the former Eastminster Presbyterian Church), legal description: *WALROND PLACE LOTS 1 & 2 & S 6.67' OF LOT 3 BLK 2 (KNOWN AS TR 2 ON CERT SUR S-3 PG-64), Kansas City, Jackson County, Missouri.*

A minimum sale price has been set by the Session and agreed to by the Trustees below which the Trustees must approve.

The minimum amount is not made public at this time to allow the congregation latitude in the sale negotiations and to avoid any conflict of interest concerns that might arise.

(B.) The Council recommended that Presbytery approve the minutes of the October 19, 2009, stated meeting of Council.

(C.) The Council recommended that Presbytery approve the minutes of the November 17, 2009, stated meeting of presbytery.

(D.) The Council recommended that Presbytery approve the change of location for the stated and called meetings of Presbytery Council to the Linwood United Church in Wesley Hall.

(E.) The Council recommended that Kaw Prairie Community Church host the September 2010 presbytery meeting and that First, St. Joseph host the February 2011 presbytery meeting. *NOTE: A flyer with all the council and presbytery meeting dates and packet deadlines is in the FYI section of the presbytery packet.*

(F.) DELETED: The Council recommends a 2% increase in their effective salary for the Executive Presbyter, Acting Associate Executive Presbyter and Stated Clerk for 2010.

First, Kansas City, KS Administrative Commission Report:

While giving thanks to God for the nearly 129 years of mission and ministry in Wyandotte County, the Presbytery of Heartland dissolves the congregation of First Presbyterian Church, Kansas City, Kansas, effective June 2, 2010.

A Celebration of the Mission and Ministry of the First, Kansas City, Kansas was led Elder Harold Frye from the Administrative Commission and Clerk of Session Sandy Nuessen. The presbytery participated in a litany of thanksgiving for the mission and ministry of First, KCKS, while a photographic montage was projected on the screen.

The Stated Clerk moved approval of the Consent Agenda. It was seconded and approved.

Minute for Mission: Stewardship Kaleidoscope

Elder Mary Jorgenson encouraged all the churches to send participants to Indianapolis for the national stewardship event March 15-17.

Heartland Presbyterian Center

Elder Dan Scheneman presented an update on the Center and its financial and programmatic challenges. 2009 was the Center's best financial year! The Center is paying down its debt to the presbytery and building up their cash reserves. Mr. Scheneman thanked many persons including the volunteers who donate time during camping season, those who provide skills to repair and improve the facilities and named the many churches that have committed to "Second Mile" giving to the Center. The Center's video "Be a Hero" was shown to the presbytery and Program Director Michael McGraw reminded the opportunity to participate in "TLC" which is preparation of the camp on April 24, 9:00 – 3:00 and reminded the presbytery how much the camp has been part of everyone's life.

Committee on Preparation for Ministry

Rev. Glenda Watts, Moderator of CPM, led the presbytery through the examination for ordination of **Amy Ramirez-Spears** which included her growth between the time of her certification ready to receive a call and receiving a call; her understanding of the atonement; her understanding of the sovereignty of

God and she affirmed her ability to answer all the constitutional questions for ordination in the affirmative including agreeing to governed by its polity and abide by its discipline.

The presbytery conducted further examination of the candidate's Christian faith and views in theology, the Bible, the Sacraments, and the government of the church as it deemed necessary which included her understanding of God as Father and Redeemer; how does she plan to baptize using the Trinitarian formula; and how she has changed or grown during the inquirer/candidacy process.

Mrs. Ramirez-Spears was escorted out of the meeting place. There were no questions for the Committee on Preparation for Ministry. **Rev. Dick Pierson moved that the examination for ordination cease.** It was seconded and approved.

The presbytery being fully satisfied of the candidate's qualifications, **CPM moved that the Presbytery approve Candidate Amy Ramirez Spears to be ordained to the Ministry of Word and Sacrament.** The motion was approved and Mrs. Ramirez Spears was welcomed back into the meeting to applause.

Rev. Glenda Watts led the presbytery through the examination for ordination of Bonnie Grabowski which included her growth between the time of her certification ready to receive a call and receiving a call; her understanding of "fully human and full divine" and its relevance to today; her understanding of her relationship with God; her excitement about serving as pastor in Savannah; and she confirmed her ability to answer all the constitutional questions for ordination and installation in the affirmative include agreeing to governed by its polity and to abide by its discipline.

The presbytery conducted further examination of the candidate's Christian faith and views in theology, the Bible, the Sacraments, and the government of the church including her perception of what may be her first challenge in being pastor in a small church.

Mrs. Grabowski was escorted out of the meeting place. There were no questions for CPM or COM from the presbytery. **Elder Terry Miller moved that the examination cease.** It was seconded and approved.

The presbytery being fully satisfied of the candidate's qualifications, **CPM moved that the Presbytery approve Candidate Bonnie Grabowski to be ordained to the Ministry of Word and Sacrament.** It was approved and Mrs. Grabowski was welcomed back into the meeting with applause.

Minute for Mission: One Great Hour of Sharing

Rev. Carla Gentry encouraged participation in the One Great Hour of Sharing which benefits the Presbyterian Hunger Program, the Presbyterian Disaster Assistance and the Self-Development of People program in one minute!

The Moderator announced that the **Presbytery Offering** was \$1,172 and will be divided equally between the Interfaith Hospitality Network of Johnson County and the Community Mission Fund of the Harold Thomas Center for Reconciliation.

At 12:00 p.m., the presbytery recessed for the **ORDER OF THE DAY**. Rev. Jeff Clayton shared grace before the meal.

At 1:00 p.m, Moderator Herring **reconvened the Presbytery with prayer.**

Minute for Mission: Shared Mission Giving

Elder Mary Jorgenson explained how shared mission giving multi-tasks by supporting many of the wonderful missions and ministries in the presbytery, synod and General Assembly in less than a minute!

Report of the Executive Presbyter

Rev. Charles Spencer responded to a question about a follow up report on the work of the Administrative Commission's work with the Gashland church. In late September, several members of the presbytery expressed belief they could help effect a moment of reconciliation between the presbytery and Gashland to enable a conversation between the church and the presbytery but those efforts were declined by Gashland. Legal action began in late November two months following the presbytery's approval of taking legal recourse. He highlighted the new residency program sponsored by General Assembly for churches to share a pastor and the local Face-To-Face in April for pastors seeking calls and PNC's to meet and interview each other.

Congregational Development & Redevelopment

Rev. Dan McKnight and Rev. David Cliburn explained the history of the Arabic-speaking fellowship and Samir Awad spoke to the presbytery about their fellowship. Members who attend are originally from Lebanon, Egypt, Iraq and Palestine. They worship every Saturday night at 7:00 p.m. in the Grace Covenant Presbyterian Church sanctuary.

The Division moved that the Presbytery receive the Arabic-speaking fellowship currently meeting at Grace Covenant Presbyterian Church as an immigrant fellowship of the presbytery called the Arabic Presbyterian Fellowship.

The motion was approved.

Mission and Social Justice Division

Rev. Al Zimmerman led the division in its report. Elder Jane Piper reported for the **Guatemala Partnership** and the current issue of Presbyterians Today has an article about the July trip celebrating Maya Quiche's 25th Anniversary. She challenged the presbytery be "be in mission" instead of just doing mission. Churches in Guatemala will begin to propose projects so that Heartland churches can partner with a sister church to assist in completing that project. The next trip to Maya Quiche will be this fall. Partnership mugs were presented to the presbytery moderator, executive presbyter and stated clerk.

Community Mission Grants Report was included in the presbytery packet.

The **Thwake Village** Travelers were commissioned by the presbytery for their trip departing February 22, 2010. Rev. David Nzioka, Rev. Kirk Perucca, Rev. Jarrett McLaughlin, Larry and Joan Bechtel, and Rev. and Mrs. Al Zimmerman. The projects include construction of a church, a medical clinic and a bore hole.

Rev. Kirk Perucca invited the presbytery to the April 24th **Festival of Peacemaking and PW Spring Gathering**.

Church Order and Listening

Rev. Heidi Peterson, Moderator of the Church Order and Listening Division along with some its members presented each overture received from a session without recommendation for approval or disapproval of each session's request.

Rev. Heidi moved for COAL that each speaker in debate be limited to 2 minutes. It was seconded.

The motion received a 2/3 majority approval.

Overtures concerning G-6.0106b:

Rev. Jason Carle, a member of the division gave a framework of the overture from the Central Presbyterian Church Session concerning G-6.0106b and G-14.0450.

Rev. Rachel Lancey, a member of the division gave a framework of the overture from the Grace Covenant Presbyterian Church Session concerning G-6.0106b.

Elder Avis Odenbaugh, a member of the division gave a framework of the overture from the Brookdale Presbyterian Church Session requesting an authoritative interpretation of G-6.0106.

On behalf of COAL, Rev. Heidi Peterson moved the overture from Central Presbyterian Church Session concerning G-6.0106b and G-14.0450 be approved.

Elder Neta McCall from Central Presbyterian Church spoke to the motion then the debate opened to the floor.

The Session of Central Presbyterian Church, Kansas City, Missouri, respectfully requests Heartland Presbytery to overture the 219th General Assembly (2010) to do the following:

1. Direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

a. Strike the current text of G-6.0106b and insert new text to read as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

~~“b. Those who are called to office in the church are to lead a life in obedience to Scripture and in conformity to the historic confessional standards of the church. Among these standards is the requirement to live either in fidelity within the covenant of marriage between a man and a woman (W-4.9001), or chastity in singleness. Persons refusing to repent of any self acknowledged practice which the confessions call sin shall not be ordained and/or installed as deacons elders, or ministers of the Word and Sacrament. Those who are called to ordained service in the church, by their assent to the constitutional questions for ordination and installation (W-4.4003), pledge themselves to live lives obedient to Jesus Christ the Head of the Church, as revealed in Holy Scripture, striving to follow where He leads through the authoritative witness of the Scriptures, and to understand the Scriptures through the instruction of the Confessions. In so doing, they declare their fidelity to the standards of the Church. Each governing body charged with examination for ordination and/or installation (G-14.0240 and G-14.0450) establishes the candidate’s faithful efforts to adhere to these standards.”~~

b. Amend G-14.0450 by inserting a new paragraph “b.” and by re-lettering current paragraphs “b.” through “d.” as “c.” through “e.” The text shall read as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

“Final Assessment of Readiness to Begin Ordained Ministry

“In the final year of theological education or when a candidate has satisfied all of the requirements of this section, and before the candidate has received a call, the committee on preparation for ministry of the candidate’s presbytery shall conduct a final assessment of the candidate’s readiness to begin ordained ministry. A summary of this assessment shall be reported to the presbytery and shall be transmitted to a calling presbytery when requested. The committee on preparation for ministry shall report to the presbytery when it has certified a candidate ready for examination for ordination, pending a call. This consultation shall focus on the outcomes of inquiry and candidacy and shall include each of the following requirements of certification:

“a. demonstration of readiness to begin ministry of the Word and Sacrament as required to fulfill the candidacy phase of preparation;

“b. *demonstration of readiness to assent to the constitutional questions for ordination and installation;*

“b. c. presentation of a transcript showing satisfactory grades at a regionally accredited college or university, together with a diploma;

“~~e. d.~~ presentation of a transcript from a theological institution accredited by the Association of Theological Schools acceptable to the presbytery, the transcript showing satisfactory grades, and presentation of a plan to complete the theological degree including Hebrew and Greek and exegesis of the Old and New Testaments using Hebrew and Greek texts;

“~~d. e.~~ presentation of satisfactory grades together with the examination papers in the five areas covered by the Presbyteries’ Cooperative Committee on Examinations for Candidates.”

The motion was approved.

On behalf of COAL, Rev. Heidi Peterson moved the overture from Grace Covenant Presbyterian Church Session concerning G-6.0106b be approved.

Elder Kevin Mason from Grace Covenant Presbyterian Church spoke to their overture to the presbytery then debate was opened to the floor.

The Session of Grace Covenant Presbyterian Church, Overland Park, Kansas, respectfully request Heartland Presbytery to send the following overture to the 219th General Assembly (2010).

The Presbytery of the Heartland respectfully overtures the 219th General Assembly of the Presbyterian Church (U. S. A.) to direct the Stated Clerk to send the following amendment of the Book of Order to the presbyteries for their affirmative or negative votes:

To delete the current text of G-6.0106b and to substitute the following:

b. Standards for ordained service reflect the church’s desire to submit joyfully to the Lordship of Jesus Christ in all aspects of life (G-1.000). The governing body responsible for ordination and/or installation (G-14.0240; G-14.0450) shall examine each candidate’s calling, gifts, preparation, and suitability for the responsibilities of office. The examination shall include, but not be limited to, a determination of the candidate’s ability and commitment to fulfill all requirements as expressed in the

constitutional questions for ordination and installation (W-4.4003). Governing bodies shall be guided by scripture and the confessions in applying standards to individual candidates.

After a brief comment, the overture was approved.

Rev. Tom Thomas registered his dissent to the previous action of the presbytery as he felt it was redundant to send both the Central and Grace Covenant overtures to the General Assembly.

On behalf of COAL, Rev. Heidi Peterson moved the overture from Brookdale Presbyterian Church Session concerning an authoritative interpretation on G-6.0106b be approved.

Elder Vernalee Carter, a member of the Brookdale Presbyterian Church, spoke to their session's overture.

The Session of Brookdale Presbyterian Church, St. Joseph, Missouri, meeting on January 31, 2010, respectfully requests Heartland Presbytery to overture the 219th General Assembly (2010) of the Presbyterian Church (USA) in Minneapolis, Minnesota, to issue the following authoritative interpretation of the Presbyterian Church (USA) Constitution:

The 219th General Assembly declares that church officers and ministers of Word and Sacrament may in good conscience disagree with constitutional requirements for both faith and behavior. Nevertheless, the constitution of the Presbyterian Church USA, while allowing freedom of conscience in interpreting the Scripture (G-6.0108 a), also requires that in becoming candidates and officers, members of the Presbyterian Church USA choose to exercise their consciences within certain bounds. "His or her conscience is captive to the Word of God as interpreted in the standards of the church so long as he or she continues to seek or hold office in that body." G-6.0108 b shall be understood to mean that no governing body may grant an exception to any explicitly stated behavioral standard for ordination and that church officers are to remain in compliance with such standards. Consequently, any person declining to comply in practice or refusing to comply in stated intent is ineligible for ordination or installation or for candidacy as an officer or minister of word and Sacrament, and shall not be ordained, installed, validated, or reinstated to active ministry by any governing body. We recognize the church's responsibility to counsel with and care for those whose consciences lead them to disagree with standards adopted by consent of the whole church and urge our particular churches and governing bodies to counsel and minister to such persons at all times with Christ's love and moral clarity.

After a brief debate, the motion failed.

Rev. Tom Thomas moved that a commission be formed with two session members of Central Presbyterian Church and two session members of the Grace Covenant Presbyterian Church with members of Church Order and Listening Division to combine the two previous approved overtures into one single overture before sending it to the 219th General Assembly.

The Moderator ruled the motion out of order as both overtures had been approved without amendment.

Overtures concerning the meaning of Christian Marriage:

Rev. Mark Hughes, a member of COAL, gave a framework for the overture from the Brookdale Presbyterian Church Session concerning the definition of marriage.

Rev. Pat Jackson, a member of COAL, gave a framework for the overture from the Central Presbyterian Church Session concerning same gender marriage in states where it is legal.

On behalf of COAL, Rev. Heidi Peterson moved the approval of the Brookdale Session's overture concerning an authoritative interpretation of W-4.9001.

Elder Vernalee Carter, a member from Brookdale, spoke to their overture which seeks to eliminate moral confusion on the definition of marriage.

The Session of Brookdale Presbyterian Church, St. Joseph, Missouri meeting on January 31, 2010, respectfully requests Heartland Presbytery to overture the 219th General Assembly (2010) of the Presbyterian Church (USA) in Minneapolis, Minnesota, to issue the following authoritative interpretation of section W-4.9001 of the Directory for Worship of the Book of Order:

The church's constitutional definition of marriage is found not only in this section of the Directory for Worship (W-4.9001) but also in the Book of Confessions (6.131 and 6.133-134) This understanding of marriage is also expressed or assumed in at least two other passages in the Book of Confessions (5.246, 9.47) and at least one other passage in the Book of Order (G-6.0106b). If the church were to discern a need to change its constitutional definition of marriage, good church order and constitutional consistency would require that appropriate amendments be made to both parts of the Presbyterian Church (USA) constitution. Amendments to the Book of Order definition of marriage shall not become effective unless corresponding amendments to the Book of Confessions have also been approved.

The overture failed .

On behalf of COAL, Rev. Heidi Peterson moved approval of the Central Presbyterian Church Session's overture requesting an authoritative interpretation concerning same gender marriages.

Elder Neta McCall spoke to the Central Presbyterian Church's overture.

The Session of Central Presbyterian Church, Kansas City, Missouri respectfully requests Heartland Presbytery to overture the 219th General Assembly (2010) of the Presbyterian Church (USA) in Minneapolis, Minnesota, to issue the following Authoritative Interpretation of the PC(USA) Constitution:

Since several states have recognized that marriage is a fundamental right for all persons, and since the definition of marriage in the Directory for Worship can be interpreted as descriptive and therefore does not mandate that a marriage contract must be only between a man and a woman, the 219th General Assembly declares that in the states which authorize same-gender marriage, pastors may officiate at such marriages in the context of Christian worship.

After a brief debate, the overture was approved 70-65.

Presbytery Council

Elder Jack Schrimsher reported on January 25th Meeting and Retreat and presented the following motions:

The motion was approved.

Report from Synod Commissioners

Rev. Ryan Kapple, Synod Moderator Elect and Rev. Rachel Lancey, Moderator of Mission Personnel, presented the background on the Council's motion. In early 2008, the synod established a mission study task force made up of members from all the presbyteries in the synod. After the task force completed its work in 2009, the October 2009 synod assembly voted to temporarily suspend its bylaws and standing rules for 2010 to allow a re-structuring.

The Presbytery Council recommends the Presbytery's concurrence with the Synod's action at their October 15, 2009, assembly meeting to change the manner in which presbyteries are represented at the synod level to 24 commissioners, four from each presbytery including two elders and two ministers.

The motion was approved with some dissenting votes.

Business Affairs

Elder Bond Faulwell provided an overview of the **presbytery's financial status** as of December 31, 2009. The Statement of Activities showed that the year ended in the black for both per capita and shared

mission. The Statement of Financial Position, Per Capita Report and Shared Mission Report ending 12/31/2009 were included in the packet. Shared Mission Giving rebounded and ended the year in the black.
